

Introduction

This is the programme of Governor Training courses available to all Bury Governors for the rest of the academic year.

All Governors whether new or old are very welcome to attend – governance is constantly evolving and there is always something new to discover!

All of these courses will be offered online using the RMA Zoom account. Each course will be 2.5 hours in duration (including a 15 minute screen break) and cover the same material as an in-person workshop – which we hope to offer again from September 2021.

These interactive sessions combine whole group discussions, small group / break out discussions, quizzes and tutor led sessions. You will receive a small pack of pre-course reading, and a full pack of course information afterwards.

How Do I Book?

You can book onto these courses by clicking on the booking link for each course on the table on the following page. This takes you to an event booking service which will record your booking, issue your ticket and enable us to send you all the pre-course information. The only data you will share is your name and email address.

Each course will have its own unique Zoom link which will be issued directly to you once you book on.

You can't access a course without booking ahead, and numbers for each course are limited to ensure the best experience for everyone.

Bookings close 2 working days before the course date, and courses with less than 6 delegates will be cancelled 1 week before the scheduled start date.

What Do I need?

All you need is a device which has a camera, microphone, speaker, a reliable internet connection and a modern internet browser (Chrome, Edge, Safari etc),. The courses will work on a phone, but a tablet is better and a laptop or desktop will give you the best learning experience.

This course is a full day course in person, and when conducted online it is split into 2 half day sessions. For delegates to gain their accreditation they will need to complete an interactive assessment, which can be completed either during the course. Alternatively they can print this off and do the assessment afterwards Based on an understanding of offender behaviour to:

- Identify the key features of staff recruitment that help deter or prevent the appointment of unsuitable people
- Consider policies and practice that minimise opportunities for abuse or ensure its prompt reporting
- Help participants begin to review their policies and practice in recruitment with a view to creating a safer culture
