#### **Autumn Term 2020**

### **GOV 01:** HT Performance Management and Staff Appraisal

Governors play a key role in Headteacher performance management and staff appraisal. This briefing will ensure that you have the correct processes in place to enable you to effectively manage the performance of your Headteacher and oversee staff appraisal.

At a time when there has been major disruption to schools due to Covid-19, this session will provide practical advice and guidance to governors and trustees on carrying out performance management and staff appraisal.

### **GOV 02:** Developing a Governance Monitoring Framework

The landscape for schools over 2020/21 presents significant challenge. Emerging 'lessons from lockdown' can help us to re-evaluate governance priorities and to review how best we can hold our school leaders to account in the current changing circumstances. The establishment of a clear governance monitoring framework and a programme of activities for the year will help individual governors to understand and evidence their contributions to effective governance and support governance impact.

The governor monitoring framework that has served us well in the past may benefit from modification to address current priorities and foci. Effective governance may require the revision of traditional roles and responsibilities and activities for Committees and Link Governors; changed focus' for independent governor research and a radical rethink on school visits! The session will review the strengths of typical governance arrangements and activities, and provide guidance on evolving practice and strategies to address the increased DfE foci including on ensuring staff, pupil and parent voice.

This session will help governors to contribute to board considerations re strategic planning and the establishment of an effective governance monitoring framework for the new school year. Specifically, the session will be of interest to Committee Chairs and Vice Chairs to support activity planning.

It will help governors develop the understanding and skills needed to review and challenge data, to set targets and to support and challenge school leaders in order to maximise pupil progress.

This session will also provide governors with the details of how primary assessment has changed and what this means for governors monitoring pupil progress in their school.

- Forging effective relationships with school staff; and
- Reporting back to committees and to the board

## GOV 10: Meeting the Needs of Vulnerable Children including SEND and Pupil Premium

### GOV 17: Well-being, recruitment and staff retention

Recruiting and retaining the best staff is an issue in many of our schools. Research has shown that the well-being of staff has a direct impact on pupil well-being and outcomes. We now know that the extent to which schools take care of staff well-being is a key factor in recruiting and keeping staff.

This training will look at the legal requirements under employment laws relating to staff well-being and will explore the role that governors can play in promoting staff's well-being and securing the best staff for their schools.

#### **GOV 18: Academy Governance**

Aimed at governors new to the academy sector, this training will support development of understanding of the specific nuances of governance within a single or multi-academy setting.

This session is specifically aimed at individuals who already have skills and experience of governance in settings outside of education or from a maintained school setting and focusses on supporting the effective application of competencies associated with delivery of robust accountability, oversight and assurance for educational and financial performance.

It will ensure that governors are clear about what constitutes safeguarding; what the role of their Designated Safeguarding Lead should be; what issues their school may be dealing with; and what their role is in terms of holding the school to account.
